

COMPETITION TERMS AND CONDITIONS

1. Prize Pool and Individual Prizes

- 1.1. The total physical prize pool is valued at USD \$6,000
- 1.2. The actual/appraised value of the prize pool may differ at the time the prize is awarded.
- 1.3. The specifics of the prize pool shall be solely determined by EXOR Studios.
- 1.4. No prize substitution shall be permitted except at EXOR Studio's discretion.
- 1.5. The individual prizes and selection criteria are outlined in Section 2.

3. Eligibility

- 3.1. All eligible mods and creators will be considered for entry into the competition. If you do not wish to participate, you can opt out by sending an email to support@mod.io;
- 3.2. For mods to be eligible, the creator must:
 - 3.2.1. Have a single active member account on mod.io when the Prizes are determined and at the last day of the relevant month. Duplicate accounts will be grouped or banned;
 - 3.2.2. Have agreed to, and not be in breach of, the mod.io or The Riftbreaker Terms of Use and Privacy Policy, and any other

- 3.2.2. policies as may be required by EXOR Studios or mod.io from time to time;
- 3.2.3. Not be employed or provide services for mod.io, EXOR Studios, or The Riftbreaker, or be related to or live with someone who does; and
- 3.2.4. Live in a jurisdiction where they are able to participate in unregistered competitions for games of skill.
- 3.3. For mod(s) to be eligible, they must:
 - 3.3.1. Be your original creation;
 - 3.3.2. Be publicly available and visible on mod.io;
 - 3.3.3. Be active and not taken down from mod.io for any reason;
 - 3.3.4. Be compatible with the latest version of The Riftbreaker;
 - 3.3.5. Be correctly submitted by the submission date; and
 - 3.3.6. Comply with the relevant The Riftbreaker EULA and any other policies required by EXOR Studios from time to time.
- 3.4. Additional rules:
 - 3.4.1. If the mod is not visible on mod.io, you agree that EXOR Studios or mod.io may mirror the content from a third-party modding platform and display the mod on mod.io, for the purposes of maintaining your eligibility;
 - 3.4.2. If the mod is not visible in the Steam Workshop site, you agree that EXOR Studios may mirror the content from mod.io or a third-party modding platform and display the mod on the Steam Workshop site, for the purpose of maintaining your eligibility;
 - 3.4.3. Notwithstanding the above eligibility criteria, EXOR Studios and mod.io reserves the right to exclude any creator or mod from the program for any reason;
 - 3.4.4. Creators who are found to have acted in bad faith, in mod.io's sole discretion, will be permanently excluded from this and any future competitions;
 - 3.4.5. If a mod has been created through the contributions of multiple parties, only the primary creator, as credited on the mod page, is eligible to enter and win prizes;
 - 3.4.6. Mods that are obviously trying to "game" the system in any way to win will be disqualified from participation; and
 - 3.4.7. The decisions of EXOR Studios and mod.io staff regarding eligibility, Winner Selection Criteria, and winners of the
